18 The Presiding Judge has designated locations for where the types of cases are  
19 to be filed and heard. To process filings in a timely manner, please locate the type of  
20 case and zip code that corresponds with the place of residence or where the incident  
21 occurred. This will identify the assigned courthouse to file and have the case heard.

23 All civil unlimited cases in San Bernardino County, including those designated as  
24 complex; all unlawful detainers filed as unlimited - alleging damages of \$25,000 or more  
25 (including cases for recovery of residential COVID-19 Rental Debt if the landlord  
26 chooses not to file the case in small claims court); all actions to recover COVID-19  
27 Rental Debt involving commercial properties alleging damages of \$25,000 or more; and  
28 all probate matters shall be filed and heard in the San Bernardino Justice Center,

1 located at 247 West Third Street, San Bernardino, CA 92415, except as specified in  
2 subdivisions (a) and (b) of this order.

4 (a) Petitions for restraining orders (i.e., civil harassment, elder/adult dependent  
5 abuse, return of firearms, post-secondary school, and workplace violence, etc.) and  
6 name changes. All petitions for restraining orders and name changes shall be filed and  
7 heard in the following courthouses:

- 8 (1) San Bernardino Justice Center, Civil Division (with the exception of  
9 elder/adult dependent abuse filings, which are heard in the Probate  
10 Division), 247 West Third Street, San Bernardino, 92415.


